

The National Survey of Early Care and Education: Project Descriptions and Team Members

The National Survey of Early Care and Education (NSECE) is a nationally representative study that characterizes the use and availability of child care and early education (CCEE) in the United States. This study is funded by the Office of Planning, Research, and Evaluation (OPRE) in the Administration for Children and Families (ACF), U.S. Department of Health and Human Services.

The NSECE includes a set of four integrated, nationally representative surveys. These are surveys of: 1) households with children under age 13; 2) home-based providers of CCEE; 3) center-based providers of CCEE; and 4) the center-based provider workforce. The study uses a provider-cluster approach for sampling all four surveys from the same small geographic areas. This approach allows the NSECE to document the interaction of the supply of and demand for CCEE where it occurs—in local communities—while simultaneously capturing data that efficiently construct national estimates. Because the experiences of low-income families are of special interest in public policy addressing CCEE and school-age care, the NSECE oversamples low-income areas.

Below we describe in more detail each phase of work and include a list of team members for each effort.

Design Phase of the 2010 National Study of Child Care Supply and Demand (Design Phase)

In 2007, NORC began work on this study under a contract for the Design Phase of the National Study of Child Care Supply and Demand with partners: Chapin Hall Center for Children and Child Trends, as well as several independent academics. (See the following table for key personnel from each partner.) Over the course of the four-year contract, we constructed a design for what would be the first national study of child care supply and demand in 20 years: the NSECE. As part of this design work, the team also developed the study's innovative sampling approach and designed and tested the NSECE household, center-based, and homebased provider questionnaires to collect data on both the use and availability of CCEE. The NORC team conducted a feasibility test and assessed the results of the questionnaire design, sampling, and data collection strategies recommended for the NSECE.

2012 National Survey of Early Care and Education

In 2012, NORC built on the work completed during the Design Phase and conducted the first round of this study. We partnered again with Chapin Hall and Child Trends as well as several independent academics. (See the following table for key personnel from each partner.) To create a fuller picture of the CCEE workforce, we incorporated the classroom-assigned workforce sample into the study design, developing a questionnaire to learn more about the experiences of individuals working directly with children in the center-based classroom. Data collection took place between November 2011 and June 2012. We gathered information from roughly 11,000 households with young children, 12,000 center-based and home-based providers, and 5,500 individuals working with children in center-based classrooms. This study provided the first national data on child care supply and demand in over 20 years and refreshed the available knowledge about the types of providers of child care as well as the needs, constraints, and preferences of families with children age 12 and under. The 2012 NSECE generated urgently needed information about the provision of early care and education and school-age care across the country and spanning many sectors of care providers such as Head Start, family day care, and after-school programs, as well as informal care provided by families, friends, neighbors, and nannies.

Enhancing Analytic Capacity of the 2012 NSECE

NORC developed a suite of public-use and restricted-use data files based on the 2012 survey data. In 2015 NORC began work enhancing the analytic capacity of the NSECE data under a new contract. This work includes providing support to researchers using these NSECE data files. This support involves answering questions from data users and providing trainings and developing technical resources to help build skill and capacity among the CCEE research community. In addition, we developed a process for providing access to the most sensitive NSECE data through a secure work environment at NORC. We shepherd research teams from the initial application process to the final disclosure review of their results, offering support and assistance throughout the time they are working with these data. Another important component of enhancing the analytic capacity of NSECE is conducting analytic work to answer agency questions and better understand how well the supply of CCEE matches families' needs. Over the past five years, the project team has published several reports and snapshots on various topics related to the central research questions of this study. 2019 National Survey of Early Care and Education

NORC was awarded a new contract in 2017 to conduct a second round of the NSECE in 2019 to update the 2012 profile and shed light on how the CCEE landscape has changed since the last data collection effort. To meet the objectives of this contract, we have partnered with Chapin Hall and Child Trends once again and other independent academics. (See the following table for key personnel from each partner.) In preparation for this effort, NORC updated the 2012 instruments and designed and selected the new sample. Between January and July 2019, NORC collected data from households, providers, and classroom staff. We released nine publicuse data files throughout the summer and fall of 2020 and are currently preparing restricted data files. The 2019 NSECE was expanded to include the NSECE COVID-19 Follow-up Study which focused on the impact the pandemic had on providers and classroom staff as well as the supply of CCEE available to families. It also sought to understand how to support providers and classroom staff more effectively in the face of future emergencies. The follow-up study involved re-interviewing CCEE providers and classroom staff who participated in the 2019 NSECE. The interviews took place in waves between the fall of 2020 and spring of 2022.

Support for Analytic Capacity of National Survey of Early Care and Education Public-use and Restricted-use Data, 2020 - 2025

In 2020 NORC was awarded a contract to promote the 2012 NSECE and 2019 NSECE as analytic and methodological resources for ACF and the broader CCEE community. This project provides researchers with access to highly restricted data that includes geographic identifiers and other identifying information to conduct analyses at different levels of geography, including national, state, and sub-state levels. The NSECE team supports requests for data, assists with disclosure concerns, and provides guidance on issues related to the design of the NSECE. The NSECE team also provides training and technical assistance - through tutorials, webinars, codebooks, and other resources - to address the CCEE research community's diverse needs. It also supports OPRE's policy and research needs and seeks to address pressing questions from the CCEE field through analyses that require an in-depth understanding of NSECE sampling approaches and inter-relationships across the household, provider, and workforce samples and survey years, exploratory analysis of restricted-use data, and the use of research methods that are novel in the CCEE field, as well as product creation and dissemination. 2024 National Survey of Early Care and Education

NORC was awarded a new contract in 2021 to conduct a third round of the NSECE. The 2024 NSECE will document the availability and use of CCEE across the U.S. It will capture families' needs, preferences, and choices of non-parental care for children under age 13, alongside providers' child care and early education offerings. The 2024 NSECE will also build on findings







from the 2012 and 2019 NSECE to allow for comparisons of supply and demand of child care and early education over the 12-year data collection span. The data will also support examination of the ways in which the child care and early education field responded to policy initiatives between 2012 and 2024, including the period covering the COVID-19 pandemic.

To meet the objectives of this contract, we will continue our partnership with Chapin Hall and Child Trends and other academics. (See the following table for key personnel from each partner.) In preparation for this effort, NORC is updating the 2019 instruments and designing and selecting a new survey sample. We will collect data from households, providers, and classroom staff between November 2023 and August 2024.
