

## **2025 Faculty Views on Academic Pluralism Survey Random Drawing Official Rules**

### **1. Overall**

- A survey completion is not necessary to enter or be selected in the 2025 Faculty Views on Academic Pluralism Survey Random Drawing (herein referred to as “Faculty Views Survey”).
- The mode of entering the drawing will not improve your chances of being selected.

### **2. Eligibility**

- The Random Drawing is open only to faculty members in the United States who were invited to participate in the 2025 Faculty Views Survey.
- Eligible Random Drawing Entrants must be employed by a U.S. college or university and hold a faculty position during the 2025 Faculty Views Survey data collection period.
- Eligible Random Drawing Entrants must have reached the age of majority in the U.S. state they physically reside by November 10, 2025.
- Each eligible faculty member may enter the drawing only once regardless of mode of entry.
- Employees of NORC at the University of Chicago (NORC) and their immediate family members are not eligible for the Random Drawing.

### **3. How to Enter**

Faculty may enter the Random Drawing in one of two ways:

#### **a. Automatic Entry via Survey Completion**

- Faculty members who are eligible for and complete the 2025 Faculty Views Survey will be asked at the end of the survey if they would like to be entered into the drawing. Those who do will be automatically entered in the drawing.

#### **b. Mail-In Entry Without Survey Completion**

- Faculty who do not complete the survey may enter by mailing a 4" x 6" index card containing the following information on separate lines of the index card:
  1. “2025 Faculty Views Survey Random Drawing”
  2. “A283”
  3. First and last name
  4. College or university
  5. Faculty position
  6. Department
  7. Email address used to receive the survey invitation
  8. Survey ID (found at the bottom of the survey invitation email)
- Mail the index card in a No. 10 envelope to: **2025 Faculty Views Survey Random Drawing (A283)**, c/o NORC at the University of Chicago, 55 East Monroe St., 19th Floor Chicago, IL 60603-5901.
- The return address must be the faculty member’s college or university.

### **4. Entry Deadline**

- All entries via the survey or mail must be received by **December 17, 2025, 11:59 pm PST**, the close of the Faculty Views Survey.
- For mail-in entries, postmarked entries by the deadline are not sufficient—they must be received by the deadline.

## 5. Drawing Details

- The Random Drawing will occur on or about **January 5, 2026**.
- Awardees will be selected at random from all eligible entries.
- Selected Entrants will receive **one** Amazon gift code.
- No Entrant is eligible for more than one award.

## 6. Disclosures

- You have not yet won.
- The entry period ends December 17, 2025, 11:59 pm PST.

## 7. Random Drawing Awards

A total of **100 Amazon gift codes** will be awarded:

- Random Drawing Awardees (i.e., selected Entrants) will be determined in a Random Drawing from among all eligible entries received by December 17, 2025, 11:59 pm PST.
- Odds of being selected depend on the number of eligible entries received on or before December 17, 2025, 11:59 pm PST.
- The estimated odds of being selected are **1 in 40**, based on anticipated number of entries.
- Awarded Amazon gift codes are non-transferable and no substitutions will be made.

## 8. Notification

- Selected Entrants will be notified via the email address provided in the 2025 Faculty Survey or on the mailed-in index card.
- Notifications will be sent **on or after January 5, 2026**, and **no later than January 30, 2026**.
- Entrants who are not selected will not be notified.
- Selected Entrants' names will not be made public.

## 9. General Conditions and Limitations of Liability

- No purchase or survey completion is required to enter or win.
- Incomplete, inaccurate, or duplicate entries will be disqualified.
- NORC reserves the right to verify eligibility and to modify or cancel the drawing if necessary.
- Unauthorized groups, clubs, or organizations are not permitted to reproduce or distribute any portion of these Official Rules to its members or staff.
- Entry into the Faculty Survey Random Drawing constitutes your consent to participate in this Random Drawing and your consent for NORC to use the Entrant's name and email address, and other information solely for the purpose of administering this Random Drawing.

- Entrants agree to these Official Rules and the decisions of NORC, and on their behalf, their respective heirs, executors, administrators, legal representatives, successors.
