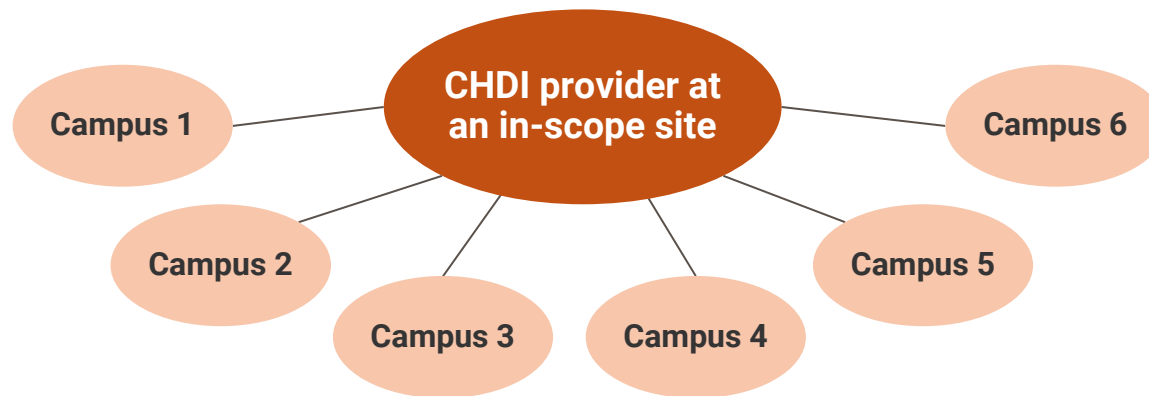

- Enables the mobilization of care to expand provider reach — powers remote consultations on par with a face-to-face visit
- Disrupt traditional care delivery — create new pathways that reduce costs, and improve convenience and patient outcomes
- Flexible and customizable mobile medical infrastructure
- Optimized for use with mobile cellular service and Wi-Fi
- Live video, audio, clinical and lab data streaming, and remote telediagnostic device control
- Provider access through web browser — no software to install; EHR integration available
